General Information and Conditions TRWC Art Center 2011 "Hats Off To Art" Show Submission Form

Eligibility

- Must reside in San Juan County, New Mexico
- Works must be original.
- Limit of 2 hats per artist.
- Entries must have been created within the last 12 months.
- Entries must be for sale.
- Entries must not be copies, derivatives, or based on other copyrighted material.
- Entries must be ready to display.
- All paperwork including submission form and inventory list, fees, and hats must be submitted during normal operating hours and days between June 21 and June 25, 2011. No exceptions.

Fees **\$10** Submission Fee **per hat** (applied to cash awards and promotional costs)
20% of sales on July 1, 2 and 4, 2011
40% of sales for non-members from July 5 through July 30, 2011

Photography The TRWC reserves the right to photograph entries for the purpose of documentation, education and publicity.

Liability Every reasonable precaution will be taken by Three Rivers Women's Collective (TRWC) during the receiving, installation, exhibit and return of work. Work should not be so fragile that public display would be potentially harmful to the work or the viewer.

The exhibitor agrees to hold harmless Three Rivers Women's Collective, TRWC Art Center, In Cahoots! Gallery, and any of its directors, officers or volunteers from any damage or loss of exhibitor's property. TRWC, TRWC Art Center, In Cahoots! Gallery or its volunteers will not assume any liability for loss or damage, however incurred.

Artwork shall remain the property of Artist until sold. TRWC shall provide due diligence, but the Artist shall be responsible to provide insurance for all shortages, loss, or damage, while artwork is under the control of TRWC.

Proceeds of Sales TRWC will pay to Artist proceeds as described in this agreement. Checks for proceeds will be issued by the 5th day of August 2011. Winners of cash awards will be determined and checks issued by the 5th day of August 2011.

TRWC reserves the right to remove from the exhibit any item which does not meet the eligibility requirements, standard of quality, or which may be considered unsuitable or objectionable for a family-oriented show.
